The HCAA announces examinations (initial and re-examination) for ATPL, CPL and IR according to Part-FCL The examinations will be based on the latest release of the EASA ECQB (2022).

## **DATES**

- 1. Starting date of the theoretical knowledge examination (initial and re-examination) for ATPL, CPL and IR according to Part FCL is the **19th of September 2022**.
- 2. Examination days and groups in detail will be announced on the 09/09/2022

### **APPLICATION**

- 1. Candidates for participation in the examination or re-examination must submit the relative **Application**. For **Initial** examination additionally they shall submit the provisioned attachements.
- 2. Candidates shall submit detailed appropriate documents proving all previous examination results, mentioning examination sitting and dates.
- 3. The **Application form**, shall be submitted to the Flight Standards Division (A2-C Licensing Section).
- 4. The **deadline** for receiving the application is the **02/09/2022**.

#### **EXAMINATION FEES**

- 1. For examinations an examination fee of 15 euro per subject is needed to be submitted.\*
- 2. For re-examinations a re-examination fee of 15 euro per failed subject is needed to be submitted.\*
- On said documents shall be depicted explicitly the subjects it refers to.
