# **Guidance for the new HCAA Flight-Crew Licensing Application Forms**

This Information Notice contains information that is for guidance and/or awareness.

# 1. Introduction

On Friday, 30<sup>th</sup> of June 2023 the Hellenic Civil Aviation Authority issued new application forms for the Personnel Licensing office, and more specifically for the Flight Crew Licensing section of the Department.

Further applications that use the old Y.P.A (Currently known as H.A.S.P – Hellenic Aviation Service Provider) Forms shall not be accepted.

However, applications using such format that have been sent to <a href="mailto:info@hcaa.gov.gr">info@hcaa.gov.gr</a> until 10 August 2023 will be settled & concluded.

### 2. Scope

The Hellenic Civil Aviation Authority has deployed a suite of new forms and standardized the Flight Crew Licensing applications in order to provide clarity and ease to administrative staff and Flight Crew, while at the same time abiding by all the relevant legislative requirements as set out in 1178/2011 as amended.

# 3. Application Combinations

In order to make the application process much more efficient, all of the forms have been standardized except for specific forms that are utilized for complex functions. Additionally, to make the application process much smoother & comprehensive to conclude, a table for every license category will be provided below to be utilized by the respective administrative staff. Keep in mind that PEL-FCL is a generalized designator for the Flight Crew Licensing Forms followed by a unique number for every separate application. When the form number is followed by "A" or "H", that means that the specific application is for the "Aeroplane" or "Helicopter" category respectively.
