SUMMARY OF PROCLAMATION

The Civil Aviation Authority announces the launch of an electronic open tender based on the award criterion of the lowest price for the designation of a contractor for the 'Operation of Regular Airlines on which public service obligations have been imposed' for a period from **01-02-2023 to 31-01-2027**.

The competition will take place using the platform of the National Electronic Public Procurement System (ESIDIS) through the system's web portal www.promitheus.gov.gr.

Period of validity of tenders: three hundred (300) calendar days from the day following the closing date for submission of tenders, with an extension of 300 days.

The budget is: EUR 72,736,000 EUR (not including VAT 24 %).

The language is: GREEK

Guarantees: Letter of guarantee for participation of an amount equal to 2 % of the budgeted expenditure excluding VAT, per line.

Upon signature of the Contract, a performance guarantee of 4% of the total compensation requested, excluding VAT, will be lodged. The amount of the letter of guarantee may not be less than forty thousand euros (EUR 40 000.00) including in the case of zero compensation, per line.

All air carriers holding a valid operating licence granted by a Member State either on the basis of Council Regulation (EEC) No 2407/92 on the licensing of air carriers or Regulation (EC) No 1008/2008, and in particular Chapter II thereof, on the basis of 'Operation Authorisation', shall be entitled to participate in the tendering procedure.

Payment method: The payment of the corresponding financial compensation to be paid to the air carrier for the route will be made after each quarter, starting on 1 February 2022 (and in case of delay in starting the Contract proportionally for the first quarter) and within 30 days from the date of issue of the relevant invoice(s), in accordance with the legal provisions on the basis of:

- flights actually performed during the quarter,
- the corresponding amount — for the services actually provided — of the financial compensation requested for the period in question.
- In order to receive the financial compensation, the air carrier must notify the Financial and Administrative Support and Legal Affairs Division of its account held with a bank recognised in Greece.
